


Monthly Incident Comparison 2013 to 2014

During July 2014, Village of East Troy Police Officers handled or responded to 246 incidents. This level of activity compares to July 2013 when officers recorded 215 incidents.




Cases referred to the District Attorney's Office – 5

In July 2014, these included 1st Degree Sexual Assault of a Child, Bail Jumping and Disorderly Conduct.




Juvenile Cases Referred to the District Attorney's Office – 0

Juvenile cases are referred due to the severity of the incident or the repetitiveness of the offender. There have been no juvenile cases referred to the District Attorney's Office in June or July.




Municipal Citations – 22

Traffic Citations are issued for violations of the Wisconsin Vehicle Traffic Codes and are issued for both moving and equipment violations, which include Operation of a Motor Vehicle While Intoxicated.
