



## Monthly Incident Comparison 2015 to 2014




During July 2015, Village of East Troy Police Officers responded to or handled 220 incidents. This compares to July 2014 when officers handled 253 incidents.

## Adult Cases referred to the District Attorney's Office –21



## Juvenile Cases referred to the District Attorney's Office – 0




## Municipal Citations – 17
